**14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ A CASH DISTRIBUTION WAS PAID TO HOLDERS OF GASLOG PARTNERS LP COMMON UNITS ON 02/09/2023. THE 02/09/2023 PAYMENT TOTALED \$516,879 ON 51,687,865 UNITS. GASLOG PARTNERS LP DID NOT HAVE SUFFICIENT CURRENT OR ACCUMULATED EARNINGS FOR THE 2023 TAX YEAR. THEREFORE, A PORTION OF THE 02/09/2023 DISTRIBUTION IS TREATED AS A NON-DIVIDEND DISTRIBUTION AND SHOULD REDUCE THE BASIS OF THE GASLOG PARTNERS LP COMMON UNITS FOR THE 2023 TAX YEAR.
