14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ A CASH DISTRIBUTION WAS PAID TO HOLDERS OF GASLOG PARTNERS LP COMMON UNITS ON 07/12/2023. THE 07/12/2023 PAYMENT TOTALED \$171,254,570 ON 52,211,759 UNITS. GASLOG PARTNERS LP DID NOT HAVE SUFFICIENT CURRENT OR ACCUMULATED EARNINGS FOR THE 2023 TAX YEAR. THEREFORE, A PORTION OF THE 07/12/2023 DISTRIBUTION IS TREATED AS A NON-DIVIDEND DISTRIBUTION AND SHOULD REDUCE THE BASIS OF THE GASLOG PARTNERS LP COMMON UNITS FOR THE 2023 TAX YEAR.

COMMON UNITHOLDERS WHO RECEIVED THE 07/12/2023 DISTRIBUTION MUST REDUCE THE BASIS IN THEIR UNITS BY 62.6659% OF THE \$3.280000 PER UNIT.

SHOULD THE ABOVE REDUCTION EXCEED THE AMOUNT OF ADJUSTED BASIS, THE EXCESS IS TO BE TREATED AS A CAPITAL GAIN.
